The program has been granted accreditation for further 3 years. **Rathinam Technical Campus, Rathinam Techzone Campus, Pollachi Main Road, Eachanari, Coimbatore-641 021, Tamil Nadu** should submit fresh online application under First Cycle SAR Tier II June 2015 document through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.
